
Participant Driven

Teen Service & Leadership



Teens are empowered to become leaders in their community and prepared for wherever their future will take them. Teen programs offer advanced leadership and skill-building, and are great for individuals, clubs, or groups.

Counselor-in-Training (CIT) Teens entering 11th and 12th grade can apply for positions in our learning-intensive leadership program at Camp Kirby's overnight camp. They participate in a six-week program spread over two summers geared toward preparing them for future positions on Camp Kirby's staff through mentoring, skill-building, and experiential learning.

Teens in Action Teens develop project planning and leadership skills through service. They are empowered to identify community needs and take action to make an impact in their community. This youth-led and youth-driven program is guided by trained adults who act as mentors.

Counselor-Assistant-Training (CAT) Teens entering 9th and 10th grade learn valuable leadership skills, assist with different activity areas, and support camper groups while practicing their new fundamental skills at Day Camp.

Camps & Outdoor Education

Campers learn how to interact and become part of a community by planning their own program at their developmental level. They build self-esteem and confidence with challenge activities, archery, climbing wall, canoes, and outdoor living. Youth make new friends and have the time of their lives!

Resident/Overnight Camp Campers entering 1st through 12th grade attend half and one week themed overnight camp programs. They take part in activities that are designed to build self-worth, confidence, and individual growth while incorporating Camp Kirby's extraordinary natural surroundings.

Day Camp Youth enjoy the unique features of Camp Kirby and engage in activities such as archery, crafts, swimming, outdoor cooking, and one optional overnight. Imaginations are ignited through this three to five day themed adventure offered to ages K through 10th grade.

Outdoor Education Youth thrive in exciting learning experiences through hands-on projects and activities that increase environmental awareness and appreciation for the world around them. The power of nature awakens a child's senses, curiosity, and desire to learn. This collaborative program shared with teachers, parents, and school administrators influences students' lives and makes a positive impact on the environment.



School Year Programs

Children and teens are empowered to manage their time in a way that aligns with their individual passions and talents. Our highly trained, caring staff engage youth by gathering input to incorporate into Camp Fire activities.

Classic Club Program Members create friendships, find their spark, and develop confidence through educational activities, projects, experiences, and events. In fact, activities are limited only by the members' imaginations! Youth ages 3 through 18 meet weekly, bi-weekly, or monthly throughout the year in indoor and outdoor "classrooms".

Enrichment Classes Youth engage in hands-on activities with theme-based curriculum through After School and Community Classes throughout Whatcom and Skagit County. Nurturing, constructive, and inspiring environments allow youth to discover their spark. Each course is six to eight weeks long for youth in K through 8th grade.

Day Away Youth learn valuable skills and participate in new adventures, while spending time with their peers in a safe and energizing environment. Classes and activities are in Whatcom and Skagit Counties on out-of-school days.

Home School Programs Youth experience hands-on activities, leadership opportunities, learning through communication, and group problem-solving through programs that are created specifically for Home School Families. Youth have the opportunity to choose from science, Spanish, and art in our Bellingham, WoHeLo Room.



2019 Highlights

- We served 597 youth through after school Enrichment Programming at two Skagit and six Whatcom County schools!
- Camp Fire National announce the appointment of Greg Zweber to President and CEO. Mr. Zweber brings extensive experience in board recruitment, fundraising, financial management, youth development, and organizational stabilization and growth.
- Camp Kirby Resident Camp added another full week of Resident Camp bringing operations to a total of six weeks.
- Camp Fire Samish & Camp Kirby's Annual Dinner and Auction was the most successful one yet, raising \$61,577.
- The Dash to Disney Fun Run was a great success and will be added as a yearly event. Thank you to Disney for the park pass prizes!
- Camp Fire National sponsored two of our staff members to attend the David P. Weikart Youth Program Assessment training in Texas. Implementing a nationally known and utilized, standardized assessment will help with quality evaluations and provide data for grants.
- We received a New York Life Grant for a middle school expansion program to take place in 2020.
- We were honored with a Margaret Carile 3 year grant for inclusion and diversity.
- We received multiple scholarships for our staff to travel to trainings, from Camp Fire National. This is due to our commitment to our quality programming and mission.
- Camp Fire National granted Aspen Lindsay, a Teen in Action youth, a scholarship to attend the Youth Leadership Experience in Kansas City.
- Sasha Powers, Membership Manager, was one of 25 people chosen for a Scholarship for Emerging Leaders in Camp Fire.
- Candy Sales were moved to November. It was a great success. Thank you to all who bought candy and supported Club Kids.
- Camp Fire Samish has a 100% giving board of caring professionals, who each give their Time, Talents, and Treasures.




